All ages are invited to share in a walk to view and learn about the animals and plants that rely on these seasonal wet areas and the benefit of vernal pools. The second event to be hosted is entitled: "Take a Walk on the Wild Side" at the Steere Hill Conservation area from 10:00 am to 11:30 am on April 24th. Paul Dolan, past president of RI Wild Plant Society, will point out native plant communities in RI and the vital role they play in our environment. After the walk, RI native tree saplings will be offered to participants.

VI. Resolution - Discussion and/or action

A. Opposition of House Bill #7985 "An Act Relating to Towns and Cities - Low and Moderate Income Housing"

Councilor W. Steere stated that a bill has been introduced by the House that would impose a fine on communities for each housing unit below their requirement and would let communities buy credits from each other.

Councilor Burlingame stated his opinion that this legislation is the result of the Obama administration and the Raimondo administration attempting to force distribution of low and moderate income housing on various communities. Councilor Burlingame stated that we are 288 units below the 10% for which the penalty is \$2,000 per unit. Councilor Burlingame stated that he feels that this legislation is absolutely onerous and is recommending that the Town Council adopt the following Resolution in opposition:

Resolution #2016-08 In Opposition of House Bill #7985 Low & Moderate Income Housing

WHEREAS; the Glocester Town Council and the residents of the Town of Glocester support the concept of establishing a goal for a percentage of the housing units in the Town to be classified as low and moderate income housing; and

WHEREAS; the Town of Glocester currently requires 10% of the housing units in new

developments to be priced and categorized as low and moderate income affordable; and

- WHEREAS; the Town of Glocester does not have municipal water and sewage facilities which reduces the opportunity for the construction of large multi unit developments where low and moderate income units could be incorporated; and
- WHEREAS; a very high percentage of new home building permits issued in the Town of Glocester are for individual residences that do not lend themselves to be constructed and categorized as low and moderate income type units; and
- WHEREAS; the Glocester Town Council and the residents of Glocester believe the penalty, outlined in House Bill #7985, of a fine in the amount of \$2000 for each unit below the 10% goal is inappropriate and places an unfair financial burden on the taxpayers of Glocester; and

NOW THEREFORE BE IT RESOLVED that the Glocester Town Council and the residents of Glocester oppose House Bill H-7985 amending current legislation regarding low and moderate income regulations and urge our local legislators to oppose this bill when it comes up before the House and our Senator should a companion bill be presented to the Senate.

IX. New Business

A. Reconsideration of Motion Re: Commitment of Funds to Glocester School Committee 5-Yr Capital Program (Funding Motion to be reconsidered due to lack of Commitment of matching School Funds) - Discussion and/or action

Discussion: Councilor W. Steere stated that we have not yet received a commitment from the Glocester School Committee, in the form of a Resolution or a vote, to put that money aside as we have done. Councilor W. Steere commented that the Council should reconsider because the trust factor between the Town and the School Committee at both the local and regional level is nonexistent, in his opinion.

Councilor G. Steere stated that Walter Steere, Jr., School Committee member, has asked to have this matter placed on the Committee's agenda, but it has not yet been addressed. Councilor G. Steere stated that we made a deal and they should keep their end of the bargain.

Walter Steere, Jr. stated that he has always said he would vote for this, but the money should be put in a restricted account so it is not spent on something else. W. Steere, Jr. stated that the Committee has been asked and he thinks it will get done.

Councilor Sette stated that when he saw that this was on the agenda, he contacted the chair of the Glocester School Committee to ask what was going on and she replied that it was her error that it

didn't get on the School Committee agenda, but they are willing to hold a special meeting to restrict the money. Councilor Sette stated that, as a result, he would ask the Council not to take a vote to reconsider tonight.

Councilor W. Steere stated that it is important that this get done before our public meeting for the Budget, adding that there may be different people sitting on the Council and School Committee in the next Budget cycle. Councilor W. Steere stated that the Council has made a commitment and it is important for the School Committee to do so too.

Councilor Sette suggested that we reserve the funds and if the School Committee decides not to, we would just not pay for any renovations. Councilor W. Steere agreed, but stated that they have had two (2) meeting cycles to be able to do this, and they have chosen not to, even after it was requested.

Councilor Sette noted that our Public Hearing on the Budget is next Saturday, therefore the School Committee would have to schedule and post a meeting next week. Councilor Sette suggested that the Council state that it should be no later than the Committee's next regularly scheduled meeting or the Council will withhold the funding.

Councilor Sette stated that he will contact the chair to let her know what transpired tonight and that the Council would like this done, preferably prior to the Public Hearing on the Budget, but if not, then prior to the Budget Referendum vote. The Council members agreed.

B. Discussion: Budget Adjustments proposed by Council for consideration at Public Hearing - Discussion and/or action

Councilor W. Steere noted that the Public Hearing is set for April 16th, 2016, 2:00 p.m. at the High School Auditorium and the hearing is being advertised.

Discussion: Councilor Burlingame stated that there was a question regarding the Senior Center Budget. Councilor Burlingame stated that there was an increase of \$2,000 in the supplies account. Councilor Burlingame expressed his opinion that there should not be a copier available to the public as this increases the cost of toner and paper. Councilor Burlingame stated that if it was only used for the monthly newsletter, the cost would be approximately \$1,400 and questioned why the Budget is \$3,500. Councilor Burlingame stated that when he was at the Senior Center recently talking to the Director, he saw many people using the copier.

Councilor Burlingame also noted that is it not just Glocester residents who use the Senior Center, stating that of the 483 members, only 175 are from Glocester.

Councilor Sette questioned several items regarding revenue. Councilor Sette asked if fees are charged for the activities and asked if they operate bingo at the Center. Councilor Sette stated that there used to be a "coffee fund" which was used to cover certain expenses and asked if the fund is still active. Councilor Sette also stated that Senator Fogarty and our Representatives could submit a request for a legislative grant which could pay for the Senior newsletter. Councilor Sette commented that there are many ways to raise money that should be explored.

Councilor Burlingame stated that Burrillville contributes \$4,000 per year and those funds should be used for activities. Councilor Burlingame suggested that the Council not agree to increase the office line item by \$2,000. Regarding the copy machine, Councilor Burlingame stated that it should be kept in the Director's office. Councilor G. Steere agreed that the increase should not be allowed.

Councilor Burlingame stated that the amount for janitorial supplies has been reduced to \$1,500, but noted that we now have outside janitorial services, therefore what level of supplies should remain. Councilor Sette recommended leaving the janitorial supplies budget for this year and if not used, we could reduce it next year.

Councilor Burlingame asked the other members if they want to reduce the office supplies budget by \$2,000. There was Council consensus to do so.

Councilor Burlingame stated that the Little League did not appear before the Budget Board for their \$3,400 allotment and noted that Public Works will no longer perform maintenance on Acotes Field in order to devote more time to improving Leja Field. Councilor Burlingame stated that he received phone calls asking the Council to allocate funds for the Little League to use for mowing by an outside vendor.

Mike Gray, board member of the Glocester Little League, thanked the Council for all the years they supported the League and apologized for not getting to the Budget Board meeting to discuss their request. M. Gray noted that Bob DiGiulio of the Little League was at the last Council meeting at which time he stated that the Board was fine this year and would prefer that the Town put that money toward Leja Field instead. However, M. Gray stated that they have received price quotes for cutting the fields and it would cost the League between \$6,000 and \$8,000 for the season. M. Gray stated that the lack of funding from the Town and the cost of cutting would create a deficit, which was not planned when registration fees were set. M. Gray stated that the Board members, parents and coaches are willing to help by maintaining the infields and the Director of Public Works has agreed to continue to cut the outfields.

Councilor Sette mentioned that Major League Baseball is accepting applications for field renovations and suggested that this grant opportunity be pursued. Councilor Sette stated that he will forward the link to the Mike Gray.

Gary Treml, Director of Public Works, spoke regarding what needs to be done at Leja Field, stating that it will cost a substantial amount of money. G. Treml further stated that somebody will have to go there every day to water the grass. G. Treml asked who would be using the field and if it justifies the amount of time and effort that will be invested.

Councilor Sette suggested applying for recreation grants from DEM. Councilor Burlingame agreed. Councilor W. Steere stated that we should have the Recreation Director come up with a plan, adding that it is our property and should be kept up accordingly.

Councilor G. Steere stated that water would be needed at the field and a dug well could be installed, but it would take money to do so and to provide the electricity to run it. There was Council

consensus to ask the Planner to work with the Recreation Director with regard to obtaining grant funding.

There was Council agreement to move \$2,000 from the Senior Center budget to that of the Public Works Department/Building and Grounds. (Action to be taken at the Public Hearing on April 16th.)
