Councilor G. Steere stated that the applicant is requesting: An outdoor bar for sales (service) of alcohol (diagram in packet).

Discussion: David D'Agostino, attorney representing the applicant, stated that the applicant is here to request permission to serve, and not just consume, in the outdoor area as defined on the documents submitted with the license application.

Councilor G. Steere commented that the previous owner had outdoor service. Tim Kane, Town Solicitor, stated that he does not know if they had a bar outside or if they allowed their servers to bring drinks outside. Councilor G. Steere stated that he attended a fundraiser there and there was a small bar outside. D. D'Agostino stated that during certain events, they would have a beer tub outside from which a server would operate.

D. D'Agostino stated that the request is weather permitting. Councilor W. Steere asked if it would be a permanent structure and if it would only be beer and wine. Albert Hill, applicant, replied that it would be a seasonal structure and only beer and wine would be served. Councilor W. Steere commented that it might not be a "horrible" idea because there would be a bartender providing supervision.

Councilor G. Steere stated that he spoke with Joseph DelPrete, Chief of Police, regarding this request and the Chief stated that he has no issues with it. Councilor W. Steere pointed out that if there are any problems, it comes back to the Council and it could be revoked.

Councilor G. Steere asked if anyone in the audience wished to be heard for or against this application.

Councilor Reichert asked if the applicant is aware that he has to apply for outdoor entertainment. D. D'Agostino replied in the affirmative and stated that their application is on the agenda under Sections I and J. D. D'Agostino further stated that they are also aware of the Special Event requirements. Councilor Reichert commented that there is always concern for the neighbors because noise travels.

Councilor Henry stated that the applicant is not asking for a Special Event license tonight. D. D'Agostino replied that is correct; they are applying for outdoor service, entertainment and outdoor entertainment. Tim Kane pointed out that this item is only for outdoor service.

J. ENTERTAINMENT LICENSE

REQUEST FOR OUTDOOR ENTERTAINMENT - Discussion and/or action

1. Hill's Tavern and Grill, LLC, d/b/a Hill's Tavern and Grill, 417 Putnam Pike Councilor G. Steere stated that this Public Hearing was advertised in the Observer/Valley Breeze on Nov. 1st, 2018 and abutters notices were sent.

Councilor G. Steere DECLARED the Public Hearing OPEN.

Councilor G. Steere stated that the applicant is asking for the following (per his atty): "To follow our meeting from this morning, attached please find the "entertainment license" expansion plan prepared by my clients for 417 Putnam Pike. They would like to expand their entertainment license to add (weather- and seasonal permitting) outside entertainment. The entertainment would be located on the 20' x 16' raised wooden patio depicted on the attached plan.

Their request would be for bands and/or DJs, which would be set up in/on that area and all sound projections would be towards the rear of the property (towards the volleyball court area.)"

Discussion: David D'Agostino, attorney for the applicant, stated that they are here to request outdoor entertainment as set forth in the memo read by the Council president. D. D'Agostino noted that the drawing submitted is similar to the one for the expansion of alcohol sales, but they have identified the area where a DJ or band would be set up.

Councilor Reichert asked how often they wish to have outdoor entertainment, stating that the residents do not want to hear music every weekend. Councilor G. Steere stated that in the past, the Council allowed it every other weekend. Councilor Henry stated that this was for Special Events.

Albert Hill, Jr., applicant, stated that it would be a seasonal thing, weather-permitting, on weekends, during the day, a couple of times per month. Councilor G. Steere asked what time the music would end. A. Hill, Jr. replied that they would like permission for entertainment from noon to 8:00 p.m.

Councilor G. Steere stated that noise travels and even if you don't think you have neighbors, it affects people. Councilor Henry commented that music is subjective and asked if it will be heavy metal, light rock or acoustical. Councilor Henry stated that just saying "music" is open-ended and the neighbors will want to know what type of music is planned. A. Hill, Jr. replied that the genre is more acoustic or bluegrass and more on the mellow side. D. D'Agostino reminded the Council that the Hill family has made a significant investment in town and are gearing their business towards the restaurant aspect as opposed to a bar.

Councilor Henry stated that the applicants will have to nail it down to more specific dates and times. D. D'Agostino stated that they could provide a supplement to the Council.

Councilor W. Steere stated that he would prefer that the entertainment be acoustic with no amplification, because there have been no issues in the past. Councilor W. Steere stated that with DJ's and drums, it becomes subjective and hard to quantify. Councilor W. Steere noted that due to the geography of the area, noise carries and you can actually hear people talking in the parking lot from some of the neighbors' houses.

Councilor G. Steere commented that it would be in the applicant's best interest to stay on top of this and stated that if there is a problem, the Council will address it.

Councilor W. Steere agreed that more details are needed regarding the frequency and type of entertainment. Councilor Henry stated that she would like to see some specific plans once the applicant has finalized booking the musicians.

Councilor W. Steere asked if this would become more of a Special Event. T. Kane replied that it could morph into a Special Event if they are having something they don't normally have, such as a bike run or a car wash. T. Kane stated that he has heard that the applicant wants to have entertainment as a normal course of business. T. Kane stated that the Council, as the Licensing Board, could put any stipulations they wish. T. Kane stated that this could be continued and the applicant could come back with a schedule of entertainment. T. Kane further stated that there are neighbors present who want to be heard.

Councilor G. Steere commented that it is tough to nail down dates because you never know what the weather will be, but the Council could limit it to three (3) of four (4) days per month.

Councilor G. Steere stated that we will now hear from the neighbors:

1. David Piccirillo, of 456 Putnam Pike, stated that his property is located opposite the tavern. D. Piccirillo stated that he is against the outdoor entertainment license for many of the reasons that have already been addressed. D. Piccirillo stated that at night, he can hear everybody in the parking lot during the volleyball games. D. Piccirillo further stated that he is a musician and knows that bands book far in advance. D. Piccirillo noted that the kind of bands the applicant is looking for need amplification or it won't sound right, stating that acoustic with no amplification will not be heard by anybody in the crowd.

Regarding having entertainment every Friday, Saturday and Sunday, D. Piccirillo stated that he would be 100% against that. D. Piccirillo stated that he wouldn't have a problem with holiday weekends. D. Piccirillo again stated that he can hear conversations in the parking lot, but it is quick and goes away, unlike hour after hour of music.

Councilor Reichert concurred with D. Piccirillo and stated that he was told about the problem 10 years ago by D. Piccirillo's daughter.

2. Bob Deroche, of 60 Farnum Road, stated that his house is a mile away from the establishment and the music will be facing in his direction. B. Deroche stated that he does not have a problem with the time frame, noon to 8:00, that the applicants have stated. B. Deroche stated that he appreciates that they will go to 7:00 or 8:00 at night and be done, and supports them doing it within the parameters that they have stated. B. Deroche stated that he wouldn't want it every night of the week, but he has no problem with the request as presented.

3. Missy LaPlante, of Absalona Hill Road, stated that she has lived there for over 20 years. M. LaPlante objected to the music, whether at night or during the day, stating that it impedes on her happiness. M. LaPlante stated that she does not have a problem with acoustic, but not every weekend. M. LaPlante stated that in 20 years, the only complaints she has had have been regarding that building and the previous owners. M. LaPlante stated that when that business closed, it was the quietest it has ever been, but now the new owners want to take up where they left off.

Albert Hill responded by saying that he understands but in that regard, he has turned away the motorcycle activity and has spent a fortune turning around the atmosphere. Regarding the outdoor entertainment, A. Hill stated that they wish to be respectful to the neighborhood which is why they have limited the days and hours. A. Hill pointed out that they are asking for 12:00 to 8:00, but nobody will play for 8 hours; it may be 12:00 to 4:00 one day and 4:00 to 8:00 another day. A. Hill further stated that it will not be every day on the weekend but just once a week.

Councilor Reichert asked if Mr. Hill will also want Special Events. A. Hill replied that he does not know where this business will take them. Councilor Reichert explained that they are two (2) separate things; the applicant could come back to request a special permit for a motorcycle run. Councilor Reichert stated that the neighbors are the Council's number one concern.

4. Robin Tyo, owner of Cady's Tavern, stated that they have dealt with the problems the applicant is dealing with, due to the way the neighbors were treated by the previous owners. R. Tyo stated that it took a long time, but she closes the outdoor bar early and has acoustic music from 2:00 to 6:00 p.m.

Councilor Reichert noted that the last time Cady's Tavern was before the Council, the Lake Association backed them because they took what was there and turned it around. Councilor Reichert stated that the applicants must prove themselves.

- D. D'Agostino stated that if the Council wants to see a more detailed idea of dates and times, the applicant can provide that and come back at the next meeting. Councilor Reichert stated that the Council needs more information. Councilor Henry agreed that it is important for us to have dates outlined so we and the Police Chief to know what is going on.
- D. D'Agostino asked, in terms of notice requirements, for consideration to continue this hearing to a date certain to eliminate any further advertising. Councilor Reichert stated that a motion could be made to continue the hearing without prejudice. Councilor W. Steere stated that before a motion is made, we should have some clarity between the Town Council and the applicant. Councilor W. Steere asked T. Kane if the applicant has outdoor music one or two days per month, does that fall under Special Events and should they be looking at it that way. T. Kane replied that if they are just doing it in the ordinary course of business, that is what they are limited to right now.
- D. D'Agostino stated that they are not asking for a Special Event license at this time, but he cannot say that they never will ask for it. D. D'Agostino noted that the Hills have undertaken an investment and are trying to turn away from the atmosphere that was there prior to them taking over. Councilor W. Steere stated that he looks at it as a "clean slate" but the Council has no history with the new owner. Councilor W. Steere again stated his opinion that once or twice a month fall more to a Special Event. T. Kane replied that, based on our definition of Special Event, it would have to be a major sporting tournament, fund raiser, car wash or

bike run. T. Kane stated that they want to do their normal business, but have entertainment outside.

Councilor G. Steere commented that Robin Tyo had "words of wisdom" and advised the applicant to try to scale it down to a couple of times a month. Councilor G. Steere further stated that if they came to the Council for a Special Event, it would not be another event but would take the place of one of these dates. Councilor G. Steere stated that we have heard from the neighbors who have put up with a lot, although it had nothing to do with this applicant. Councilor W. Steere agreed and stated that having acoustics would be a good starting point.

5. David LaPlante, of Absalona Hill Road, stated that his experience with the last owners was not good. D. LaPlante stated that he does not understand the need for outdoor bands and does not see how this would make the business better. D. LaPlante stated that he is opposed to outside bands because he has the right to enjoy his summer too. D. LaPlante stated that special events happen, but he does not want to see it as a regular thing.

MOTION was made by Councilor W. Steere to CONTINUE the Public Hearing regarding the Entertainment License Request for Outdoor Entertainment, for applicant: Hill's Tavern and Grill, LLC, d/b/a Hill's Tavern and Grill, 417 Putnam Pike until the meeting of December 6, 2018; seconded by Councilor Reichert.

Discussion: None.

Councilor Henry asked if this applicant does not apply for a Special Event license during this time period, are they able to come back any time next year and apply for it, or do they need to do it now. T. Kane replied that we stress having them come in at once, but he does not think that we totally preclude it. Councilor Henry stated that she does not want the applicant, since they are new at the business, to miss an opportunity because they did not understand the Council's process. T. Kane read from the Ordinance which states that application must be made no less than 30 days prior to the date of the special event.

Request for miscellaneous 2019 Special Events with outdoor Entertainment Councilor G. Steere stated that this Public Hearing was advertised n the Valley Breeze on November 1, 2018 and abutters were notified.

Councilor G. Steere DECLARED the Public Hearing OPEN and stated that this request is for the following events: 5 - Music Dates; 5 - Art Festival Dates; 5 - Vendor Dates.

Discussion: Councilor W. Steere asked if these 15 different events are all outdoors. Dan Smiley, Applicant, replied in the affirmative, stating that he is asking for 15 potential events, but does not have anything lined up yet. D. Smiley stated that he hopes to have one (1) amplified event per month at the venue. Councilor W. Steere referred to the previous discussion regarding outside entertainment, stating that this applicant has more neighbors. Councilor Henry inquired what the timing would be for the amplified events. D. Smiley responded that his thought was 4:00 to 10:00, but if that is an issue he could roll that back. Councilor W. Steere noted that even the events at the former Sticks Tavern were in the afternoon and no more than four (4) hours.

Councilor W. Steere asked the applicant to explain what a "vendor day" is. D. Smiley replied that vendors would set up inside and sell their products and he would like to also do a fine arts show, where artists would display and sell their artwork. Jean Fecteau, Town Clerk, stated for the record that for these vendor-type events, there is the possibility that other licenses would have to be obtained from the Town Clerk's office.

Councilor W. Steere stated that the applicant will need a parking plan and a safety plan before the Town can issue a permit. Councilor G. Steere explained that, even if the Council approves something tonight, the applicant still has to come in to the Town Clerk a minimum of six (6) days

in advance of each event to file an application. D. Smiley stated that he understands that.

Request for Exception for increased cost & debt to income ratio- Discussion and/or

Councilor G. Steere read the following request from the Finance Director:

Memo: Exception to Debt to Loan Ratio

Date: November 13, 2018

The Town of Glocester has been advised there is a request for a loan from the Glocester Community Septic Loan Program. The address of the Glocester property is 114 Pinecrest Drive and owned by Andrew and Blanca White. The debt to income ratio has exceeded the town's criteria of 45%.

The loan request is for an estimate of up to \$20,000 for a ten year term. The monthly payment on \$20,000 will be \$183.98.

The White's began the process for the loan in July. Since that time Blanca's place of employment has filed for bankruptcy. She is now self employed and receiving some income which is not eligible for consideration by RI Housing due to the limited experience.

The ratio listed includes the full mortgage for a second property located in Massachusetts. Rental income is not considered based on their latest tax return. Mr. White indicated the rental income covers the cost of the property.

The White's have good credit scores and history. They are asking to have the exception presented to the Town Council for approval.

Lee- Ann Gagnon of the Rhode Island Housing has provided additional comments about the loan request. This has been included for your review.

Your approval is required for the loan to be granted. (End of memo)

Councilor G. Steere read the following correspondence from R.I. Housing, which was referenced in the Finance Director's memo:

November 8, 2018

Re: Andrew and Blanca White, 114 Pinecrest, Glocester, RI 02814 Loan Amount: \$20,000.00 for 10 years Monthly Payment \$183.98

Dear Ms. Brennan:

I am writing to you requesting an exception for Andrew and Blanca White's loan application through the Glocester Community Septic Loan Program. Their debt to income ratio exceeds the town's program loan criteria of forty-five percent (45%). Mr. and Ms. White's current debt to income ratio is one hundred percent (100%) per their current credit report. The White's have maintained good credit and good credit scores. All the accounts listed on the credit report are in a current status. This is their primary residence. The combined loan to value will be 99.65%. This is based on the mortgage balance and the amount requested for the loan (\$20,000.00) for the project added together and divided by the town's assessed value of \$232,200.00.

Per Ms. White they received an estimate in the amount of \$16,000.00. However I do not have a copy of the estimate. Ms. White said she is waiting for the installer to supply them with a more detailed estimate that includes materials and labor.

Please advise us in writing by November 30, 2018 if you would like Rhode Island Housing to move forward with the loan application. If you have any questions, you may reach me at (numbers provided).

Discussion: Andrew White, loan applicant, stated that the debt to income ratio is high, but he and his wife have excellent credit and are never late with their monthly obligations. Councilor G. Steere asked if the septic system has failed. A. White replied in the affirmative and stated that he has an repair estimate of \$16,000. A. White stated that they were advised to ask for \$20,000. Councilor Reichert noted that the Whites are having the system pumped, which is expensive. Councilor Reichert advised Mr. White that the Town will have a lien on the property in the event of a default.

MOTION was made by Councilor Reichert to **APPROVE** the exception of debt to income ratio, at 100%, on the Rhode Island Housing loan application, for property located at 114 Pinecrest owned by Andrew and Blanca White, through the Glocester Community Septic Loan Program, November 2018; seconded by Councilor W. Steere.

Tim Kane, Town Solicitor, explained that there is a 1976 mobile home at the park for which all taxes are paid. T. Kane stated that the current owner of the mobile home is deceased and a probate estate was opened but no one has claimed the property (trailer). T. Kane stated that the mobile home is not worth anything and there are no other assets. T. Kane stated that they want to demolish the mobile home and bring in a new one, but need permission from the Town as it is the Town's collateral. T. Kane advised the Council not to exercise the Town's right to the collateral because it would cost much more that it is worth.

MOTION was made by Councilor W. Steere to authorize the Town Council president to sign releases and/or discharges of liens on the mobile home located at 10 Hemlock Drive in the Village on Chopmist Hill mobile home park, subject to the condition that RLM records the bill of sale in Land Evidence; seconded by Councilor Reichert.

D. Transfer of Town Property: (Generator from Police Dept.) To Ponaganset High School - Discussion and/or action

Councilor G. Steere explained that at a previous meeting the EMA Director, Gerry Mosca, informed the Council that he has received a grant to replace the generator at the Police Station. Councilor G. Steere stated that Gerry planned to move the current generator at the Police Station to the High School to run the wells, thereby, making it a viable shelter in an emergency. Councilor G. Steere noted that Gerry stated the school district has agreed to pay for the installation and

engineering needed for the installation.

Councilor G. Steere stated that the Clerk, EMA Director and Solicitor have discussed this and feel the Council may want to authorize the transfer of the generator as it is town property, with conditions.

Councilor Henry asked if we have anything in writing from the Business Manager of the School District. Gerry Mosca, EMA Director, replied in the negative, stating that is why there are conditions in the motion. G. Mosca further stated that the School District will not get the generator unless they accept these conditions in writing.

Councilor G. Steere stated that the Building Official has had problems with the School District not pulling permits for work that has been done and noted that the motion stipulates that permits must be obtained before we give them the generator. G. Mosca concurred.

MOTION was made by Councilor Henry to AUTHORIZE the Town of Glocester transfer of the current emergency generator at the Glocester Police Department to the Ponaganset Regional High School (following the installation of a new generator at the police department). Said transfer will be made on the following conditions: the Regional School District shall agree to be responsible for any engineering and installation costs; the Region is subject to obtaining any and all required building, electrical permits and inspections relative to the installation and operation of the generator; upon transfer to the school the Regional School District shall agree to assume all liability for the generator including all further maintenance; said generator will be used by the Region to power wells during an emergency, thereby, allowing the school to be a viable shelter during emergencies or disasters; and the Region shall acknowledge that the generator is accepted in its current condition; seconded by Councilor W. Steere.

Discussion: None.

VIII. Town Council Correspondence / Discussion

- A. Councilor G. Steere stated that a letter was received from DEM Forest Management Division regarding their America the Beautiful Tree Rhode Island 2019-2020 Grant Program. Councilor G. Steere stated that the application period ends on January 31, 2019. Jean Fecteau, Town Clerk, stated that she sent a copy to the Conservation Commission and the Tree Warden, but they have typically declined because a whole budget would have to be created.
- B. Councilor G. Steere stated that a letter was received from the City of Woonsocket stating that they have submitted a license application to the Federal Energy Regulatory Commission for a new hydroelectric license for a plant at the dam in Woonsocket. Councilor G. Steere stated that this will replace the license that will expire on October 31, 2020.
- C. Councilor G. Steere stated that the Council has received a request from George Charette for a leave of absence from the Planning Board from January through March due to medical issues.

- D. Councilor G. Steere stated that DOT sent a notice of availability for information on their proposed toll locations throughout the State.
- E. Councilor G. Steere stated that the Council received a letter from the Senior Center director stating that RISE has finished converting the light fixtures to energy efficient fixtures and bulbs in the building.

Councilor G. Steere stated that the Director reported that the Holiday Bazaar raised \$2002, despite the weather, and 110 members were signed up for the Thanksgiving meal.

F. Councilor Henry stated that she and Councilor W. Steere attended the Veterans Day event on Sunday at the Senior Center and commented that it was a great event. Councilor Henry thanked Jean Fecteau, Town Clerk, for putting the event together. Councilor G. Steere noted that J. Fecteau does a great job on that every year.

IX. Department Head Reports/Discussion

A. Diane Brennan, Finance Director, stated that Sgt. Kimberly Bertholic has been promoted to the rank of Lieutenant, effective Sunday November 25th. D. Brennan stated that this will be formally approved by the Town Council on December 6th. Jean Fecteau, Town Clerk, stated that Joseph DelPrete, Chief of Police, has asked that we have a 7:00 start for recognition of several officers and several promotions.

X. Bds. and Commissions Reports/Discussion None.

XI. Open Forum

A. Mark Rechter, of 1218 Putnam Pike, stated that a couple of weeks ago, we had the honor of having the Moving Wall at our high school. M. Rechter stated that on October 31st, in the Providence Journal, under the Veterans heading, there was an article about the Moving Wall, stating that it was coming to Scituate. M. Rechter stated that there was no mention of Foster or Glocester in the article. M. Rechter stated that he called the Journal to complain and they printed a retraction. M. Rechter stated that Channel 12 also advertised that this event was in Scituate, RI. M. Rechter stated that he has a problem with the zip code 02857 and feels that it is time to ask the Postal Service to delineate Glocester from that zip code. M. Rechter referred to a similar situation in Cranston and Johnston, stating that zip codes were changed because the residents complained that their mail was getting lost. M. Rechter mentioned several schools and businesses that are located in Glocester, but people have the perception that they are in North Scituate due to their zip code.

Councilor G. Steere agreed, stating that it is also a problem with UPS deliveries. Councilor Reichert stated that there have also been issues with phone numbers being changed. M. Rechter commented that he is proud of his town and it is time to do something about this problem. M. Rechter stated that there would have to be public hearings, but he feels it can be done.

Councilor Henry commented that the error would have been prevented if the School Committee had put out a press release about the Vietnam Wall to the media with the correct information. Councilor Henry stated that they never even advertised the event, which is a shame.

Councilor G. Steere stated that it is a continuing problem for residents with that zip code. Tim Kane stated that there is a similar situation in Smithfield, North Smithfield and Burrillville. M. Rechter stated that he is only addressing Glocester because he thought it was demeaning to our high school to say it is in Scituate, especially for an event such as this. Councilor Reichert stated that he is willing to try to get it changed. Councilor G. Steere stated that if the Council does try, they should advertise it and have a public hearing to get people's opinions. Councilor Henry commented that some people may not want to change.
