- D. Sidewalks (village area)
  - 1. Clearing Discussion and/or Action

Councilor G. Steere stated that there has been discussion quite a few times regarding plowing the sidewalks but we don't have the equipment or manpower to get involved. Councilor G. Steere stated as we now have the Pavilion and Candlelight Shopping the Council needs to decide if this is something we want to get into and if we want to spend money on a small sidewalk plow.

Councilor Forgue stated that with activities going on in Town it would be great to take care of the sidewalks. Councilor Forgue noted that people walk in the street which is extremely dangerous. Councilor Forgue stated that he is in favor of keeping the sidewalks clean as they do in Scituate and Pascoag.

Gary Treml, Director of Public Works, stated that in 2013 no one on the Council wanted to get involved with the sidewalks, and he was directed not to do anything with them. G. Treml asked if the Council now wants to change that policy. Councilor Forgue asked if G. Treml has the manpower. G. Treml replied that it would definitely have to be after a storm had passed. . G. Treml stated that there is also the question of where to put the snow if there is a lot.

Councilor Forgue stated that many people shop at Dino's and walk through town and suggested that we clear those sidewalks. G. Treml stated that if we take that on, we will have to clear every sidewalk in the Village because if you do it for one you have to do it for all.

Councilor Henry commented that in 2013 the Pavilion was not up yet and now we are having many more activities. Councilor Henry stated her opinion that it is our responsibility to do the sidewalks and we might have to add some personnel. Councilor Forgue suggested having somebody just take care of the sidewalks when needed. Councilor Forgue stated that when we did do the sidewalks, people stopped him and thanked him.

Councilor G. Steere asked if we are obligated to clear the sidewalks in front of the Town Hall and the Pavilion because we own the land. Tim Kane, Town Solicitor, replied in the affirmative.

Councilor W. Steere expressed his opinion that we could look at doing it from the Pavilion to the roundabout, but more than that would be a big expense and a lot of work.

Discussion followed on whether the need was to plow on town owned property and when to plow those properties.

After further discussion, MOTION was made by Councilor Forgue to remove snow, after (not during) a storm event, on the side walks in front of Town owned property to include: from pavilion to Town Hall (including the approx.60 feet from pavilion to Dorr Drive), the sidewalk in front of the historic district mini-park, and the sidewalk in front of the Glocester Senior Center. The extent of snow removal and sidewalk treatment shall be at the discretion of the Public Works Director; seconded by Councilor Reichert.

There was discussion regarding the type of machine needed. Councilor G. Steere spoke about a particular machine and its capabilities with attachments. Councilor Forgue asked if this machine could be used for town hall walk ways. G. Treml answered in the affirmative. Councilor G. Steere stated it sounds like this particular machine could save some time. Councilor Forgue stated that the cost of the machine they looked at would be approximately \$8,700. Councilor Henry asked where the funding is coming from. G. Treml replied that he has an account where the money can be taken from. Diane Brennan, Finance Director, spoke but was inaudible on the recording. Councilor Henry asked if this was coming out of snow account. D. Brennan agreed that was a feasible place to expend the funds from as it is snow removal. Councilor W. Steere asked if any purchasing policies are missing. D. Brennan stated she would ask for several other prices to be submitted.

MOTION was made by Councilor Forgue to AUTHORIZE the expenditure for snow removal equipment, not to exceed \$9,000.00, from the DPW budget snow account; seconded by Councilor Henry.

#### E. Pavilion

1. Winter Access - Discussion and/or Action

Councilor G. Steere stated that the Pavilion has been closed for the winter and blocks have been placed there. Gary Treml, Director of Public Works, stated that he has obtained prices for gates that would match the fence at the cemetery and it would be \$8,000, so he purchased two (2) jersey barriers to block off the driveways. Councilor Henry suggested a chain with a sign that says "Closed for the Season". Councilor W. Steere stated that people may not see the chain and drive through it.

G. Treml stated that the water has been shut off and it is not feasible to clean the facilities. G. Treml also noted that his department has never plowed there before. Councilor Henry stated that she got calls from people who thought the barriers look "off-putting", but if they need to be there, so be it.

There was agreement among the Council members that the Pavilion needs to be closed for the winter. After discussion, there was Council consensus to block off the parking lot.

MOTION was made by Councilor Reichert to close the Pavilion for the winter and put in jersey barriers; seconded by Councilor W. Steere.

Councilor G. Steere stated that the Council has received DEM plan approval for the repair of the police station septic system. Councilor G. Steere stated that the Council needs to authorize the bid process and noted that the Town Clerk has not found any MPA's for this work.

**MOTION** was made by Councilor Reichert to AUTHORIZE the Finance Director and Board of Contracts to begin the competitive bid process for the repair of the Police Station Septic System; seconded by Councilor W. Steere.

G. Taxation: Revaluation of Commercial Property - Discussion and/or Action Discussion: Councilor G. Steere stated that he received some complaints about the people who came to businesses to do the revaluation. Councilor G. Steere stated that they were including sinks in the building and decorative items as part of the business. Councilor G. Steere stated that the business owner tried to get a list of items from the gentleman but he refused.

Lori DeSantis, Tax Assessor, stated that this company, RRC, has been sub-contracted by Vision to do the businesses in Town. L. DeSantis stated that they are trained that anything you have in your

business is personal property, such as pictures on the walls. Councilor Henry stated that it is the way the tax code is written. L. DeSantis stated that per State law, everything is taxable unless exempt.

Councilor Forgue stated that it is inconsistent and in his business in Town, the tangible taxes fluctuate greatly from year to year. Councilor Forgue stated that he has let them in every year and it is all the same stuff.

Diane Brennan, Finance Director, stated that we are in a full revaluation this year and when the bid went out, it was with the understanding that we wanted to look at tangibles. D. Brennan stated that we hired an outside company to do a tangible tax assessment, which had not been done for a long time. D. Brennan stated that they could not be here tonight, but will come to a Council meeting to explain how that gets done. Councilor Henry commented that Glocester has been a little behind other towns when it comes to that tangible piece of our taxes. D. Brennan agreed and stated that hopefully, this will give us a baseline consistently from business to business within the Town. Councilor Henry stated that it is unfortunate that we even have a tangible tax because it is like a business owner is getting taxed twice.

Walter Steere, Jr. stated that if they come to his garage, he has his personal tools that may be considered part of the business. W. Steere, Jr. stated that this will make a lot of people angry in this Town. W. Steere stated that at first, he thought this was a good idea because we would get people who never paid taxes, but only those who already pay taxes are being assessed.

George Charette spoke regarding the subject of snow removal on the sidewalks, stating that when the road was done, it was advised that the street lights be placed on the backside of the sidewalk. Regarding the pavilion, G. Charette objected to the barriers blocking access. G. Charette spoke about tangible taxes, stating that when it comes to revaluation, it is a nightmare.

After further discussion, there was agreement among Council members that there wasn't anything they could do about it and that they can talk to the company in January if they chose.

H. Architectural and Engineering Design Services: Police Department Site and Building Analysis - Saccoccio & Associates Architects - Discussion and/or Action

Joseph DelPrete, Chief of Police, stated that the firm was picked from the MPA and Karen Scott, Town Planner, told them exactly what we are looking for, based on our needs assessment. Chief DelPrete stated that it is broken down into three (3) phases, the first of which is the assessment of the site with any future land acquisition, at a cost of \$11,600.

Councilor G. Steere asked how much is set aside for the septic. Chief DelPrete replied that there is \$45,000 in Capital from last year. Jean Fecteau, Town Clerk, stated that there is money set aside for a feasibility study. Diane Brennan, Finance Director, stated that we do have some money aside to put toward this.

Chief DelPrete stated that if we move forward with Phase 1, he will take care of Phase 2, then we can talk about Phase 3.

Councilor Forgue stated that this is something that needs to be done and we have to find the money for it. Councilor W. Steere asked Tim Kane, Town Solicitor, if this could be part of Capital if it is being used as an analysis. T. Kane replied in the affirmative and stated that it is for Capital improvements to the Police Station.

D. Brennan stated that as things started to fail at the Police Station, money was put into the Capital Budget to address them. D. Brennan stated that although it is identified as separate entities, they are very much connected.

MOTION was made by Councilor W. Steere to APPROVE the expenditure of \$11,600 for the architectural and engineering design services for the Police Department site and building analysis, Phase 1, from the Capital Fund; seconded by Councilor Henry.

    - K. Scott stated the Council accepted the bid from Civic Moxie to do the Chepachet Village revitalization plan and asked if she can move forward in getting the contract signed. There was consensus to add to the the January 16<sup>th</sup> meeting.
