Discussion and/or Action

Motion was made by Councilor Forgue to reconsider the vote taken -recommendation #14 elected town clerk to appointed town clerk; seconded by Councilor Henry.

Discussion: Councilor Reichert questioned how the Council could reconsider a vote previously taken and if that was legal. Atty. Kane stated he believes it is allowable legally and discussed the procedure to follow. Atty. Kane stated technically it should be done at the next subsequent meeting by a person who voted in the majority. Councilor G. Steere stated the public hearing is still open because it was continued. Councilor Reichert and Councilor W. Steere raised concerns about reconsidering this vote because the public addressed it at the last part of the public hearing and if it is being discussed again the public would still have a right to speak. Councilor G. Steere stated that the agenda was posted so people could know and can chose to speak. Councilor W. Steere stated people may not have looked at the agenda because the portion they were interested in was already voted on. Councilor G. Steere stated originally yes, but it was posted with the reconsideration. Councilor W. Steere stated this is highly irregular, in his opinion.

 Proposed Town Charter Amendments - Discussion and/or Action

 a. Proposed amendment to form of government - creation of Town Manager/Administrator position

Councilor G. Steere reminded the Council that the public hearing is still open as it was continued from last week.

Discussion: Councilor G. Steere read the proposed amendment. There was discussion as to the difference between a town manager and a town administrator. Councilor Henry stated she feels, if this is included on the ballot, the Council needs to be very specific as to this position because the town is currently trying to fill the human resources position. Councilor W. Steere stated that town managers in other communities handle human resources. Councilor Forgue stated he did research over the last week and feels a town manager is needed to handle day to day things, to work with the Council and that towns without managers can be bypassed for grants. Councilor Forgue also stated that the public needs to know of the importance of this position. Councilor Henry stated she is opening her mind to the manager but feels that it can include the human resource position and be fiscally responsible. Councilor P. Henry stated that she will do what's best but that she needs all the details. There was discussion as to whether the Council could put the brakes on the human resource position. Councilor G. Steere stated he feels there is a need for the human resource position because

it may be too long before a town manager may be in place. Councilor Forgue suggested a temporary firm to handle the human resource position. Discussion as to the cost and the description for the town manager followed. Councilor W. Steere stated that COVID has shown how complex government is and the need for a day to day person to advocate and handle items. Councilor W. Steere continued that he agrees there is a cost but it will help taxpayers in the long run.

Atty. Kane suggested the Council look at the town manager description in Burrillville, as it is a good example.

Steve Sette, resident, stated that the Council could look at ballot language used by the Town of Richmond as an example for the Town manager. S. Sette suggested that not having a residency requirement would give the Council a larger pool of applicants and to look at the Department of Business Regulation to get an idea as to compensation. Mr. Sette continued by describing the position as being more human resource on a day to day basis- managing department heads and employees; acting as a liaison between the Council and the public; and, emphasized that the town needs a strong manager because they do have some decision making authority. Discussion followed that an appointed manager as opposed to elected.

Jason Sirois, resident, stated he feels the position should be elected to take control from the Town Council.

Ted Burlingame, resident, supported the position as described by Steve Sette and disagreed with an elected position. Councilor G. Steere stated that he wants the best qualified individual and does not want it to be a popularity contest.

Councilor G. Steere asked if there was anyone else wishing to speak. Councilor G. Steere thanked everyone for their input, and DECLARED the public hearing closed .

That the following questions shall be presented to the electors of the Town of Glocester at the next General Election for their consideration:

1. AMENDMENT TO GLOCESTER HOME RULE CHARTER (Resolution of the Town Council adopted July 23, 2020)

Shall the Glocester Town Charter be amended with the addition of language to Article I, Section C1-8, Contracts with other bodies: to include that all contracts or cooperative agreements must be reviewed by the Town Council and executed by the Town Council President or designee, by vote of Town Council?

2. AMENDMENT TO GLOCESTER HOME RULE CHARTER (Resolution of the Town Council adopted July 23, 2020)

Shall the Glocester Town Charter be amended with the addition of language to Article III, Section C3-1, Financial Town Referendum, to include: Once the electors of the Town have voted on the expenditure of money at Financial Town Referendum, no additional expenditures or increases to approved expenditures shall be added without the vote of the electors with the exception of emergency expenditures made pursuant to Article VIII Section C8-10?

3. AMENDMENT TO GLOCESTER HOME RULE CHARTER (Resolution of the Town Council adopted July 23, 2020)
