Steere stated that all is up for discussion but taking acoustical out of the emergency order and put in the license makes things clearer. Councilor W. Steere stated that he is hoping that by spring we will be past all of this. Councilor G. Steere asked Councilor Reichert if he had any thoughts and Councilor Reichert responded he is fine with it.

Steere asked if then Ms. Tyo wanted to keep the 12 outside acoustic acts in the application and she stated she wanted to leave them in.

Councilor G. Steere DECLARED the Public Hearing Open and asked if anyone wished to speak for or against the renewal of these licenses.

Councilor G. Steere read Hills application for Special Events for 2021 requesting the following:

- ? Possible DJ & Bands

Discussion: Councilor G. Steere read the list of events Mr. Hill has applied for and J. Fecteau, Town Clerk, verified that there was no number stated with DJ & Bands .Councilor G. Steere reminded Mr. Hill that anything outside was unamplified and vocals is a special event that needs a license. Attorney D'Agostino, appeared on behalf of Mr. Hill. Attorney D'Agostino stated that the number of events requested is 28 events with 4 amplified music events (allowed in Entertainment License) as special events so the total is 32. J. Fecteau, Town Clerk, asked if Mr. D'Agostino wanted her to add the number 4 to DJ & Bands and Attorney D'Agostino stated yes. Attorney D'Agostino echoed what Cady's said in terms of it being a difficult year and thanked the Council. Councilor G. Steere confirmed with J. Fecteau, Town Clerk, that the total number of events being applied for is 32. Councilor W. Steere asked if the fundraiser would have outdoor amplified music. Attorney D'Agostino replied that they do not know yet because of COVID and, the time for the events being so far in advance, he asked if they could give a supplemental application six days before the event. Councilor W. Steere stated that they were looking at 14 events in May through October and further he believes that in the past they allowed something like two per month but not on consecutive days. Councilor G. Steere added that they also did allow for consecutive weekends. J. Fecteau, Town Clerk, asked if the Council wanted two events per month without consecutive days added to the special event stipulations. Councilor W. Steere said there have been issues in the past but granting 32 events with a track record that is not stellar gives him concerns. Councilor G. Steere agrees with Councilor W. Steere and says the Council should stick to two times per month for six months so he comes up with twelve events. Attorney D'Agostino agrees to two times per month for a total of twelve events and he will amend the application. J. Fecteau, Town Clerk, stated that stipulation number eight as it reads now was taken from last year's application and is for one

time per month so the Council needs to fix that stipulation if they want to allow two times per month. J. Fecteau, Town Clerk, stated that the goal in the stipulation was so that there would not be an event every Saturday and Sunday so maybe the Council needs to wait until the next meeting unless they can figure it out clearly now. Councilor W. Steere would like to be consistent. Robin Tyo, Cady's Tavern, stated her confusion with the stipulations because technically an establishment could actually have more amplified music than was originally granted. J. Fecteau, Town Clerk, stated that acoustic is part of the entertainment license which is by right and a car show would be by special event license. Councilor W. Steere stated that outside non amplified acoustic music is by right and these are special events which are different. Councilor W. Steere stated that they have run into these issues in the past and are trying to get it right in balancing the business with being good to the neighbors. Attorney Igliozzi stated that the confusion seems to be where council grants licenses by right which grants non amplified music by voice and then Council makes an exception under the special event license. Attorney Igliozzi, Town Solicitor, stated that in this case the Council is granting 32 special event licenses but limiting it to 12 -14 bands. Attorney Igliozzi continued by stating that the Council is not telling the applicant at which events they can have a band but saying they can only have twelve events of the thirty two with bands. Councilor W. Steere says the Council needs more specifics as to what the applicant wants at each event. Councilor Forgue stated that he feels the Council should do what Attorney Igliozzi suggests: allow a maximum of twelve bands but two per month and non consecutive days or weekends. Councilor G. Steere agrees and suggested that the Council made a mistake on Cady's Tavern application. Councilor W. Steere stated that an applicant can have amplified music inside and it's outside amplified music that is the issue. J. A, Muccino, Finance Director, stated he did reach out to a third company but they declined to submit an offer because they knew the Town already had a relationship with one of the companies; and, that he included the outside stand hand sanitizer as an extra option. A. Muccino stated the sanitizer stand is \$175 per month. A. Muccino corrected the quotes at:

Burrillville Cesspool - \$175 per month with weekly cleaning & \$175 monthly for additional sanitizer stand

Scituate Cesspool - \$185 per month with weekly cleaning & \$125 per month for additional sanitizer stand

Council members discussed whether to include the separate stand hand sanitizer and stated their concerns about someone taking the stand hand sanitizer. Councilor G. Steere stated that if the Council decides to do this how would it be funded. Councilor Forgue asked if the DPW had any money. Councilor W. Steere asked if the Council was going to do it now. Councilor Forgue stated that one was already there and it was paid for by Mr. Wilson, himself and the cigar store. Councilor Forgue stated it would only be for a couple of months. Councilor W. Mosca stated that the Med pod vaccine clinic will most likely be regional and there is a good possibility that Glocester will be designated as the region by the State. G. Mosca stated that he did advertise for staffing and the response has been good. G. Mosca, EMA Director, further stated that he has concerns about the vaccine, as to staffing, especially because the vaccine needs to be given in two doses and that the vaccine needs to be kept at a very low temperature. Lastly, G. Mosca, EMA Director, stated that if and when the vaccine is available, it will be given to first responders, doctors, nurses and vulnerable populations before being offered to the general public. G. Mosca stated that he anticipates the vaccine being ready around the beginning of spring

Re: Glocester Personnel Policy with respect to FFCRA and COVID19

On March 16,2020 the Town adopted a personnel policy in response to the COVID-19 pandemic where part of policy that is inconsistent with the Families First Corona Response Act (FFCRA), passed by Congress also in March, 2020. Specifically, the Town's policy is inconsistent with the FFCRA with respect to charging a given employees paid time off bank for a COVID-19 related absence.

The policy that was adopted on March, 16 2020 states that:

- "... Non-work related exposure resulting in mandatory quarantine will be covered be available leave options. Available types of leave include the following:
- Sick leave
- Family sick leave
- Annual leave (vacation)
- Compensatory leave
- Leave without pay
- Medical Leave without pay

It is this part of the Town's policy that is inconsistent with the FFCRA. According to the FFCRA: Employers must provide at two weeks (up to 80 hours) for paid sick leave for employees if the employee is unable to work because he or she:

1. are subject to a quarantine or isolation order related to coronavirus;

- 2. have been told to self-quarantine by a health care provider related to corona virus;
- 3. are experiencing symptoms of COVID-19;
- 4. are caring for someone subject to a quarantine or isolation order or who had been told to self-quarantine by a health care provider; or
- 5. are caring for their child if the child's school or childcare had been closed or otherwise unable because of corona virus.

Credit to Don Zimmerman, HR Consultant, for reviewing the Town's policy and checking the language against the language in the FFCRA and then bringing this inconsistency to my attention.

Given that the Council approved this change to the Town's personnel policy previously, I would be remiss if I did not bring this matter to the Council so that the appropriate action could be taken.

It is my recommendation, after reviewing with HR Consultant Zimmerman and Attorney Igliozzi, that the Town strike the inconsistent language from the policy and adopt the language from the FFCRA. If the Council approves this change, HR Consultant Zimmerman and I will roll-out this change to all Town Departments and Employees so that everyone is aware of this change. Respectfully submitted,

D. Proposal from Vision Government Solutions to assist the Assessor's Office with Field Work – Discussion and/or Action

Re: Vision Government Solutions Field Work Proposal

As the Council is aware, the Tax Assessor's Office Clerk has been "holding down the fort" while the Town's Tax Assessor is on leave. In order to maintain the level of service that the people of Glocester have come to expect from the Tax Assessor's Office and meet deadlines set by State Law and/or Glocester Town Ordinance the Tax Assessor's Office will require additional support.

After conferring with the Tax Assessor Clerk regarding the current and upcoming workload and how the Town might best support the Office in the interim, the greatest need for assistance is in respect to field work inspections. Typically, the Tax Assessor performs site visits in November - December in order to assess the status of various projects underway based upon permitting information provided by the Building and Zoning Office.

I have obtained a quote from Vision Government Solutions (attached) to support this effort. For \$9,600 Vision will conduct building permit inspections for 370 properties in the Town of Glocester. This expense is not budgeted for, however, if the Council agrees this is the appropriate course of action to take we could fund a portion of this expense from salary savings in the Tax Assessor's Office Budget and repurposing Education and Training and Subscription funding in the Tax Assessor's Office.

I was about to obtain at least two more quotes, given the value of Vision's quote, when I (fortunately) spoke with Building Inspector Ken Johnson regarding this matter. Ken has graciously offered to perform this field work for the Town and on behalf of the Tax Assessor's Office. This would mean additional work for Ken, which during our conversation, Ken indicated he had the bandwidth to

undertake, in exchange for comp time.

It is my recommendation that the Council charge Building Inspector Ken Johnson with this assignment in exchange for comp time. Ken will track this comp time on his bi-weekly time sheet and the Finance Office will keep record of this accumulated comp time. In my opinion, this is the most cost-effective solution that will bring necessary information into the Tax Assessor's Office in a timely manner.
