D. Glocester Scarecrow Festival, Re: Food Trucks - Discussion and/or Action Councilor Forgue asked if Mark Rechter was present and could speak to this matter.

Mark Rechter, Co-Chair of the Scarecrow Festival, stated he was speaking on behalf of the Glocester Libraries and the Chepachet Grange as sponsors of the Scarecrow Festival. M. Rechter voiced his concerns about the location and hours of operation of food trucks at the festival. M. Rechter stated that having the food trucks at the festival adds an unfair competition with the non profit vendors of food at the festival. M. Rechter stated that the festival is a one day event and the food trucks should not be allowed on that day as they take profits away from the non profit vendors. Councilor Forgue inquired of D. Igliozzi, Town Solicitor if he could look into this matter. D. Igliozzi, Town Solicitor stated that food truck registrations are mandated by the State and that the Council may grant permits. Councilor Forgue asked if Attorney Igliozzi could look into this and get back to the Council. Attorney Igliozzi, Town Solicitor, stated that he will work with J. Fecteau, Town Clerk, and have an answer for the council at the next meeting. Councilor Worthy asked if the Council has the power to black out a food truck as to hours and location. J. Fecteau, Town Clerk stated that there is nothing in our Town Ordinance allowing that.

E. Sand Dam Association - Presentation to Council - Discussion and/or Action J. Colaluca, resident, introduced J. Baker, President of the Sand Dam Association, who gave a detailed and concise explanation of the invasive species known as milfoil that is and has been an existing problem in the lake. J. Baker, stated that the Association has treated the milfoil in the lake with various interventions; has conducted education classes; and has done fund-raising to pay for these efforts. J. Baker stated that due to COVID, the Association has not been able to do the fund-raising needed to be able to purchase and apply a new type of herbicide. J. Baker stated that the herbicide costs \$22,000 and that they have \$13,000 so they are before the Council today asking for a one time request of \$9,000 for the purchase of the herbicide. Councilor Arnold thanked J. Baker for the presentation and that he is familiar with this problem. Councilor Arnold stated he applauds the efforts of the Association; and, that he is not familiar with this particular herbicide. Councilor Forgue stated that perhaps this item could be tabled. Councilor Steere stated that the Association could speak with State representatives and Senators for possible grants.

Council requested this item be placed on the next agenda

F. Regional School Committee - Financial Referendum Meeting 1/19/2021 - Discussion and/or Action

Councilor Steere voiced his concerns with the process used by the Regional School Committee at their meeting this past week in that the Board of Canvassers did not have the time required by state law to canvass and correct a list so the Region used a voter list from May 2020. Councilor Steere stated that the Region has not followed the proper process for meetings. Councilor Steere stated that this was brought to the council last year also and that the council did not act on correcting the process. Councilor Steere stated he is now bringing it before the Council again .Councilor Forgue asked D. Igliozzi, Town Solicitor for his advice. D. Igliozzi, Town Solicitor, summarized that there is a state law that allows the Region to use the voter roll from the last financial town meeting. D. Igliozzi stated that the Board of Canvassers provided that list only and they did not certify the list. D. Igliozzi stated the Board of Canvassers was not hired to run the meeting. D. Igliozzi, Town Solicitor, stated that it seems Councilor Steere's issue is directed towards the role the Town plays in the Region and that as a separate entity created by state law with authority, separate from the

Town, there is not much the Town can do. Councilor Steere stated that there is nothing the Town can do except ask the Region to follow the rules because he is worried that this is a trend. Councilor Worthy asked D. Igliozzi, Town Solicitor, if everything was done on the up and up and nothing was "snuck in" to which D. Igliozzi, Town Solicitor, agreed. D. Igliozzi, Town Solicitor, reiterated the process that occurred regarding the voter list. K. Sorenson, resident, stated that she saw the ad for the meeting in the Valley Breeze or the Bargain Buyer and that the addid not have a location stated. Ms. Sorenson stated that she called the Region to ask where the vote was to be held; and, the Region would not disclose the location but told her to wait for the agenda to come out. M. Worthy, resident and Regional School committee member, stated that the first meeting had different restrictions due to COVID than this meeting. M. Worthy stated that the Town Clerk did give the Region the voter list and that this list was used to check in the people, M. Worthy stated that the meeting was advertised; and that as Councilor Worthy and D. Igliozzi, Town Solicitor, stated nothing "sneaky" was done for this meeting of a time sensitive matter. M. Worthy stated that it sounds as though Councilor Steere is against education. M. Worthy stated that e mails from Dr. Barnes had been sent to the Town Clerk for forwarding to the Town Council and if the Council is not receiving the emails then that is another discussion that may need to be had. Councilor Steere stated that the Council had received the emails and clarified again that he is not against education but rather it is the process that concerns him. M. Worthy stated that she would like to invite Councilor Steere to the Regional meetings. Councilor Forgue stated that they all understood the viewpoints of Councilor Steere and M. Worthy. M. Worthy stated that Covid requirements have impacted meetings and it is hard to keep up with the changes. Councilor Steere stated he does not use COVID as an excuse; that Foster held their Town meeting; that Glocester did also; that he hopes the taxpayers will be allowed to show up at the meeting this year. Councilor Steere stated that he appreciates the job M. Worthy has as a school committee member; but, in his opinion, it is the process that protects people and gives them trust in the government.

Councilor Arnold stated that the advertisement could apply to any vacant positions in the Town's Board and Commissions.

(Capital Improvement Program) 2021-2022 Discussion and/or Action Councilor Forgue stated that per the Home Rule Charter the Planning Board reviews large Capital Improvement requests from Departments each year to determine if the requests are consistent with the Comprehensive Community Plan. Councilor Forgue stated the Planning Board reviewed these requests, found them to be consistent with the Comprehensive Plan and, in their motion, is asking Council to forward to Budget Board.

MOTION was made by Councilor Worthy to FORWARD the C.I.P. 2021-2022 requests, reviewed by the Planning Board, to the Budget Board for their consideration in budget preparations for fiscal year 2021/2022; seconded by Councilor Steere

Councilor Forgue offered congratulations and kudos to Councilor Arnold for his hard work. No action taken
- 2. Councilor Forgue stated that Council has received a notice from TRI Utility Cost Reductions Inc. stating they have concluded their review of our energy bills and finds their were no billing errors, therefore, they will not be filing for refunds. A. Muccino, Finance Director, stated that the notice stated that there were no errors in billing; that the Town is being billed correctly; and, that the Town does not owe any money to TRI.

- 3. Councilor Forgue stated that Council has received a request from Kady Rogler, GBA, asking the town to extend the areas in town they clear after a snow storm. Councilor Forgue stated he would like to discuss this matter with G. Treml, Director of Public Works. J. Fecteau, Town Clerk, stated that the election will probaly cost an additional \$2,500 and that she anticipates going over in her current budget as this is not an expected election.

- IX. Department Head Reports/Discussion
 Councilor Forgue inquired if any department heads wished to speak.
- 1. R. Shields, Recreation Director, stated that he wants to pay an individual who stepped in for him as the market manager at the farmers market this past summer. R. Shields felt that because he has the money in the Recreation Department account that he could just request payment from the Finance Department but he was told by the Finance Department that he

would need to come before the Council to request that expenditure. R. Shields, Recreation Director, stated that he asked the prior Council and that they did not act, therefore, he is before the new Council asking for guidance. A. Muccino, Finance Director, stated that this amount was requested in the fiscal 2021 budget for a basketball coach which was denied and as such, A. Muccino, Finance Director, did not feel comfortable reallocating the funds to a different person doing a different function. Councilor Arnold and Forgue requested this item be placed on the next meeting agenda.

- 2. Chief Delprete stated that all police have been vaccinated. Chief Delprete stated he spoke to the Human Resource Consultant and A. Muccino, Finance Director, about placing an advertisement for a shelter worker/part time animal control officer due to a resignation. Councilor Steere stated that perhaps the Council could do a citation for Officer Bertholic who recently retired at one of the next meetings to thank her for her service. Chief Delprete stated that Officer Bertholic was a great officer, dedicated to the town and he would like to recognize her.
- 3. A. Muccino, Finance Director, stated that the town reimbursed C. Wilson, resident, for money he spent for a portable restroom for public use from funds received with the "Take It Outside Grant". C. Wilson, resident, has given A. Muccino, Finance Director, an invoice for months outside the time frame of the grant. Councilor Forgue and Steere requested this item be placed on the next agenda.

Councilor Forgue inquired if K. Johnson had anything to add . K. Johnson, Building Official explained that he did not as he had been quarantining at home due to a COVID exposure.
