As noted in the attached memorandum from RI Housing, the borrowers Debt to Income ratio is at 69%, where the guidelines for the program set the DTI limit at 45%. The Town has previously approved exception requests from borrowers with much higher Debt to Income ratios and those borrowers have remained in the program and not defaulted on their obligation. Additionally, the Forgetta's are 27 years residents of the Town having owned the property since 1994.

Dear Council Members:

This correspondence is to respectfully request permission and consensus for the Police Department to utilize an <u>88 Acre parcel 12-92/93</u> of town owned land east of Stone Dam Road and South of Snake Hill Road to construct a semi-permanent outdoor firing range facility.

The police department has never had a firing range, and has relied exclusively on private property owners for the police department state mandated firearms qualifications and training.

This proposed firing range location has a natural 20 foot southerly berm that meets or exceeds national standards, with the outer perimeters secured by a natural barrier. The project would further add a second sand impact berm to environmentally protect the natural landscape and add concrete block side berms to protect any misdirected rounds along while constructing a gravel base and roadway for parking.

The outdoor range will be insured under the Town of Glocester RI Interlocal-Trust insurance umbrella policy. Signage will be posted throughout the property with a locked gate into the general range area. This range will be utilized six to eight times a year by Police Department members for qualifications/training and at least one night time training per year.

Any construction materials/costs will be funded through the police department asset forfeiture accounts.

I. Authorization for Execution and Signature-Deed of Conservation Easement, Restrictions and Development Rights, Between: Stephen E. Hopkins, Town of Glocester, Waterview Acres Homeowners Association; and Sand Dam Reservoir Association- Discussion and/or Action

Councilor Forgue stated that the Town Planner has submitted the following memo to Council which Councilor Arnold read as follows:

- Re: Deed of Conservation Easements and Restrictions and Development Rights Waterview Acres

On June 22, 2021, property owner Stephen Hopkins was granted final approval for a major subdivision. This major subdivision was approved as a conservation subdivision, dividing AP 12, Lot 134, presently consisting of 45.82 acres into 15 lots. Because the development is a conservation development, the minimum lot area for a single family dwelling is reduced down to one (1) acre; however a significant portion of the property must be preserved as open space. For this development there will be 14 single family house lots and one open space lot totaling 30.62 acres.

According to Section 350-105 A (7) of the Glocester Zoning Ordinance, which addresses conservation subdivisions, "All open space, regardless of whether it is conveyed to the Town, shall be protected against further development and unauthorized alteration in perpetuity by appropriate deed restrictions, and by the grant of a conservation or preservation restriction pursuant to Title 34, Chapter 39, of the Rhode Island General Laws, as amended, to at least three separate entities, one of which entities shall be the Town, one of which shall be a nonprofit organization, the principal purpose of which is the conservation of open space or resource protection, and one of which shall be an association of owners of lots or units within the development. If no such owners' association is created, then at least two entities shall be nonprofit conservation organizations."

This development proposes a Homeowner's Association. The applicant is requesting Town Council approval for the President to sign the attached Deed of Conservation Easements and Restrictions and Development Rights to preserve the open space in its natural form for this development. The HOA and the Sand Dam Reservoir Association are the other signatories on the document. The HOA will

maintain and pay taxes on the property. David Igliozzi, Town Solicitor, has reviewed the document and found it to be satisfactory. Karen (end of memo)

Discussion: Councilor Reichert asked as to the owners of the 42 acres. K. Scott stated that the Homeowners Association would own the land. Councilor Reichert described another property in town that he alleged had a conservation easement broken. Council members discussed the difference between an open space agreement and a conservation easement. Councilor Reichert had concerns as to future issues if the conservation easement was ever broken.

J. Plan for 9-11 Remembrance Ceremony for 20th Anniversary - Discussion and/or Action

Councilor Forgue stated that Councilor Steere submitted his ideas for a town ceremony for Council and others to consider. Councilor Forgue stated that if Council would like to proceed we will need someone to coordinate and plan, perhaps another Councilor and Councilor Steere.

Discussion: Councilor Arnold stated that he read the memo that was sent to the Town Clerk and feels it is very appropriate to do something to recognize 9/11. Councilor Forgue asked if Councilor Arnold would read the memo sent by Councilor Steere into the record. Councilor Arnold read as follows:

Hi Jean,

I wanted to put this on the agenda for discussion/action. Also, please forward this to rest of council so they can think about this prior to meeting. This will be, hard to believe, the 20th anniversary of 9/11. I was thinking that we can have some type of remembrance ceremony for this somber but important occasion at Town Hall on Saturday, 9/11/21. We should reach out to the Fire Department to see if they have anything planned. If not, what I was thinking was:

1. Start around 8:15-8:30 am (depending who attends) welcome folks who attend say a little about why we are there/national anthem

2. At 8:46 AM we could coordinate with the churches in town to see if they will ring their bell once signifying the first plane. Then we all would observe a moment of silence

3. We could say a few more words play "God Bless America".

4. At 9:02 we could then have the bells ring once again to mark the second plane/ Observe a moment of silence

5. Explain that we want to observe the Pentagon and Pennsylvania crashes and then shortly after this we could have the church(s) ring twice more to mark those two events.

6. Shortly after this we could say a few words to thank our law enforcement/fire and ems/ and military for working tirelessly to keep us safe and have the bell ring 4 more times to salute them 7. End the ceremony around 9:15 -9:20

Councilor Arnold paraphrased the rest of the memo wherein it states a question of whether the Town Hall bell works; and that (Councilor Steere) welcomes any additions ... proposing something ...to make sure to do something simple but appropriate.

> 2. Grant Agreements for the Chepachet Village National Register District Historic Revitalization Sub-grant Program - Discussion and/or Action

Councilor Forgue stated that Council has received a memo from the Town Planner which Councilor Worthy read as follows

Re: Chepachet Village National Register District Historic Revitalization Subgrant Program

Back in late 2019, the National Park Service (NPS) announced a \$250,000 grant to the Town of Glocester from the Historic Revitalization Subgrant Program to launch a local grant program for contributing structures to the Chepachet Village National Register District. Glocester was one of

only nine applicants and the only municipality to receive a 2019 award from the \$5 million program.

In late 2020, the Town invited owners of commercial and mixed use buildings that are contributing structures to the Chepachet Village National Register District to submit proposals for grants for exterior building improvements with the objective of rehabilitating historic properties in order to protect and foster economic development.

We received 11 applications requesting funds far exceeding the amount of grant funding available. The Chepachet Village Historic Revitalization Subgrant Committee, appointed by Town Council was charged with reviewing the applications and scoring them according to the criteria that was outlined in the Request for Proposals. The Committee worked to refine the scopes of work for the top three scoring applications to fit within the available grant funds. The Town's consulting architect wrote bid specifications, which were provided to the property owners. The property owners were directed to obtain two (2) quotes from contractors qualified in historic preservation and submit their preferred quote to the Town for review. The bids that were submitted still exceeded the available funds so the Committee refined the scopes further and the property owners obtained new bids, which were within the available grant funds, leaving a reasonable contingency.

The Grant Agreements that are before the Town Council have a valid bid from a qualified contractor and are currently being reviewed for approval by the National Park Service. Once the National Park Service gives their approval, the projects will be ready to begin construction once the agreements have been executed. The award of the grants was significantly delayed as the Committee felt that with the volatility in the construction industry, it was important to have valid bids for the completion of all work in the grant project rather than just awarding a dollar amount with the hopes that the work could be completed within that budget.

The grant awards are as follows:

- 1. 1157 Putnam Pike (Cyrus Cooke Inn) Tavern on Main \$112,353
- 2. 1169 Putnam Pike (Lawton-Owens Mill) Stone Mill \$66,715
- 3. 1191 Putnam Pike (Jeremiah Sheldon Tavern and Barn) \$50,926

This leaves a total contingency of \$20,006.

The request before the Town Council is to authorize the Town Council President to sign the Grant Agreements on behalf of the Town for the properties and amounts noted above. The Town Solicitor, the Rhode Island Inter-Local Risk Management Trust, the National Park Service and the Rhode Island Historical Preservation and Heritage Commission have all reviewed the Grant Agreements and are in agreement that they are ready for signature. (End of memo)

Discussion: Councilor Forgue thanked K. Scott, Town Planner for all her hard work and diligence. Councilor Forgue stated he feels she made good decisions and is happy that money has been set aside for contingencies. K. Scott stated she is very excited about the project.

MOTION was made by Councilor Worthy to AUTHORIZE the Town Council President to sign the Historic Revitalization Subgrant Program Grant Agreements for the following projects:

Discussion: Councilor Forgue asked the Finance Director for his input. A. Muccino, Finance Director, stated that the proposed request will allow the town to get rid of paper, become more efficient and bring the department into the 21^{st} century.

MOTION was made by Councilor Arnold to AWARD RFP 2021-02 for Professional Payroll Services, to Ceridian for a three year contract as follows: Year 1 - Not to exceed \$ 40, 280.80; Year 2 &3 - Not to exceed \$ 35,930.80 for payroll services for Town of Glocester employees and Glocester School employees; said contract will be forwarded to Council for approval upon receipt; seconded by Councilor Reichert

Discussion: Councilor Worthy asked about savings . A. Muccino stated that they will be able to add modules that would be at incremental expense with the current vendor; they will be able to do that with the new vendor, Ceridian, for the same money; and, he is forecasting to spend the same as with our current vendor over the next three years.

> M. Consideration of Amendment to Terms: 2009 CDBG through Western R.I. Home Repair - Interest Rate on Loan Program # 822G - Discussion and/or Action

On Friday, 7/30/2021 I received the attached communication from Town resident Paula Hesford expressing financial hardship and requests that the Council reduce the interest rate on her Western RI Home Repair Loan from 3% to 0%. Mrs. Hesford purchased a mobile home in the Village on

Chopmist Hill in August of 2009 for \$55,503.76. The current balance as of July 2021 is \$55,338.57. I have researched the history of this program as well as the status of the loans the Town is still servicing since the programs end. Of the nine Western RI Home Repair loans still active, six are 0.00% loans. One of those six was previously at 3% interest but was reduced to 0%. Two of those six loans have never received a payment. The remaining three loans are at 3% interest.

Given that the Western RI Home Repair Program was intended to assist residents purchase affordable housing or make repairs to their home and that this program was not intended to be a revenue generator for the Town. Also, given the hardship Ms. Hesford is experiencing it is my recommendation that the Council reduce the interest rate on the loan from 3% to 0%.

Councilor Forgue stated that this application was submitted and reviewed by the Clerk, Council, and others to ensure the scope was consistent with past years events.

Councilor Forgue stated that the applicant may be present to discuss the event and asked if either was present.

Discussion: M. Rechter, 1218 Putnam Pike, Glocester resident, asked that Glocester Libraries be included as they are an applicant. Councilor Forgue asked if the event is basically the same as 2 years ago to which M. Rechter stated it was. M. Rechter stated that the full schedule was submitted to the police; that the festival is all planned and they are looking for donations; described a few of the events and stated that 40 people have already signed up. M. Rechter added that the Scarecrow Festival is separate from the Scarecrow Marketplace which is put on by the Recreation Department.

MOTION was made by Councilor Reichert to APPROVE the Special Event, Applicant: Chepachet Grange #38 and Glocester Libraries for the Glocester Scarecrow Festival 2021, to be held on Saturday, October 16, 2021, with the following stipulations:

1. Any food, not prepackaged, cooked and/or served on any Town property shall be served by a certified food handler and all food applicable food safety state guidelines will be observed.

- 2. Cleanup and trash removal will be the responsibility of the Applicant, Chepachet Grange #38 and Glocester Libraries.
- 3. All stipulations for use of the Town Pavilion, in the Code of Ordinance, Chapter. 221-18, shall be followed unless waived prior to event.
- 4. The applicant, Chepachet Grange #38 and Glocester Libraries, will work with the Chief of Police regarding a Police presence for safety. The hours and number of officers needed will be at the Chief's discretion.
- 5. The applicant, Chepachet Grange #38 and Glocester Libraries, will work with the Chepachet Fire Chief to ensure all safety measures are observed and all areas are accessible by emergency vehicles.

O. Public comment on mask choice policy -Discussion and/or Action Councilor Arnold stated his opinion that there is support in the community for mask choice and thanked residents, K. Iaccobbo and C. Greathouse for their efforts as well as stating his hope that the Glocester School Committee will follow the lead of the Foster/Glocester School Committee regarding mask policy.

Councilor Arnold stated that Council has received correspondence from a resident regarding mask choice policy which he read as follows:

To whom it may concern,

I am a Glocester RI resident and parent of two school age children. I am writing in support of mask choice for students next year and to express my disapproval of the restrictions that continue to be in place in our schools.

Our family decided to home school for the 2020-2021 school year as a direct result of the overzealous restrictions that were implemented in schools not only in our state but across the country. It is illogical to quarantine the healthy and put masks on children with a zero percent risk of covid morbidity and mortality. But we did it anyway for fear of 'asymptomatic" children spreading a virus to vulnerable unvaccinated adults and their families. Believers have had the opportunity to be vaccinated and yet we continue to mask our children. This is physical and psychological abuse.

Two weeks to "slow the spread" has turned into a year and a half with no clear end in sight especially for our children. From the beginning of the pandemic the position of the federal government was to count "all suspected and presumed cases." This is bad data collection at best and outright deception at worst. Throughout the 18 months to follow they employed bad data collection and testing practices, bad use of therapeutics and ventilators, and misuse of government agencies and their emergency order powers. Meanwhile doctors and citizens who do not agree with this agenda are being censored and brought before local medical review boards. People were essentially forced to stay in their homes, wear masks and socially distance complete with daily "briefings" and DOT

signs promoting the covid agenda. Now they'll be coming "door to door" to spread the word about the vaccine. Sounds like covid-1984.

People have followed the "rules" for long enough, I am at the point where I draw the line. It has become clear that the agenda is to get everyone to get the vaccine, while openly admitting that they don't prevent the spread and are likely contributing to the "variant" situation. This vaccine has emergency use authorization, not FDA approval. While I don't believe that FDA approval holds much weight anymore, it's better than EUA. I don't believe EUA is warranted for a virus with a virtually zero percent mortality rate even with obviously padded numbers. An interesting fact about emergency use authorization is that pharmaceutical companies can't get one if there are available therapeutics or treatments. There have been several promising therapeutics, readily available, that have been squashed over the past year. I can't help but think this was due to the mission of putting the untested vaccine at the forefront of covid mitigation options. Also, let's not forget the fact that vaccine manufacturers are free from liability as it pertains to their vaccine products by way of the prep act and the 1986 vaccine injury act. Pharma companies do not have indemnity for their other products, and have faced legal action and paid out billions for the harm that many of their products have caused. Most disturbingly, products that they have known to cause harm and continued to market and sell to the consumer.

I am extremely concerned about the situation we are in. We are at a point where the burden of responsibility for individual heath has been placed on the actions of others. Wear a mask, take the shot etc. To this I say, "if your vaccine works then I shouldn't be a threat to you and if you're concerned, you wear a mask." I am afraid that vaccine mandates and passports are in our near future. This is unsafe, unconstitutional and anti civil liberties.

I seriously question that this is a "pandemic" at all and certainly not to the degree that it has been made out to be. There will be viruses forever circulating and evolving are we going to mask our children forever?

I understand that this is a unique and difficult situation to be in. Thank you for your time and consideration on this issue.

Discussion: Councilor Worthy stated his opinion in favor of the sentiments of the letter.

Councilor Arnold stated his opinion that the letter mimics the letters he has been receiving as well as his own personal opinion.

Walter Steere, 1318 Putnam Pike, Glocester resident and School Committee member stated that the committee is following the Department of Health (DOH) policy that highly recommends masks but there is no mandate. W. Steere stated that the committee had a "first reading" but the situation

may change by the time of the second reading. W. Steere stated that the Glocester School Committee received an opinion from their attorney that stated the committee has a few options regarding mask mandates and their policy. W. Steere stated that the School Committee must follow the dictates of the DOH with the only requirement being that the School Committee inform the public.

Councilor Arnold stated that the School Committee voted unanimously to not have a mask mandate which can only be overridden by DOH.

G. Mosca, EMA Director, stated that the state is leaving it up to each municipality to decide a policy as to masks. G. Mosca stated that the current DOH policy is to recommend non vaccinated people to wear masks. G. Mosca stated that the state is requiring two town clinics in September to try and get more 12-18 year olds vaccinated. Councilor Arnold asked about parental consent. G. Mosca stated that anyone over 16 years old can give their own consent.

K. Iaccobbo, 58 Granby Street, inquired if "informed consent" would be given as the vaccine is experimental. Ms. Iaccobbo inquired if the police or Council were concerned about the possibility of people going door to door asking people as to their vaccine status and making a list of people who chose not to respond.

Councilor Worthy stated his recommendation that if someone comes to your door that you do not know do not give them the option, go inside.
